Our Impact

A COLLABORATIVE PARTNER'S EXPERIENCE

As a member of the Today Family Violence Help Centre Group Case Consultation, I have been able to learn, grow, and collaborate; improving the assistance I am able to provide to my clients. I have been a member of this consultation group since early 2013, attending regularly.

This group allows me to build connections with other agencies that assist with family violence, which is invaluable as often clients involved in these cases need multiple types of help and support from a variety of sources.

As a counsellor, I am able to provide emotional support, but often these clients need supports for obtaining legal advice, help in court, and other practical needs I am unable to provide. It is so helpful to be able to collaboratively assist the client in connecting with the right people and agencies that I have met through the case consultation, which can assist them in the areas where I cannot. With the ethno-cultural population I work with, relationships are so important.

Clients feel more comfortable following through with a referral if I can tell them I know the person and how helpful they are.

Through this group I have gained much knowledge and understanding about the complexities of family violence and how to address it. My skills in **assessing, safety planning and helping the client proceed with their best decision**, have increased from the knowledge shared in the case consultation discussions. It has been so helpful to know that when I am struggling on a case, I can discuss it in the case consultation or connect with members of the group. By hearing the cases of others, I am able to gain extra knowledge of resources and issues I may not be as familiar with and how others dealt with the presented issues.

This group also provides hope as we share successes and positive stories from cases we have worked on. This is essential to working in areas of family violence as often it can be easy to focus on the difficult and negative aspects of the work. Being mindful of the success of others can help me be more confident and hopeful in the solutions I am presenting to my clients and in turn allow them to feel hope for their future.

KATE'S JOURNEY TO SAFETY

Our Impact

The past two years of my life have been like a rollercoaster. I never expected that it would take me this long to get out of my relationship. It took three attempts to get away from my abuser and at every turn Today Centre was there to support me.

My first visit to Today Centre was when my youngest son was only a few weeks old. I was already separated from my husband but he was at my house visiting the kids when he became violent. It was the **first time** the police were involved and when they gave me the number for Today Centre, I knew this time I needed help. In those first months I was connected to court support, counselling and support group resources.

I always thought it would be so easy to leave an abusive partner because I didn't realize the abuse gets worse the more you try to get away. Once I realized I needed to leave my home to stay safe, I contacted the Today Centre for a **second time**. This time we worked on applications for second-stage shelters, housing subsidy and more legal support. As I applied for and was granted protection orders and parenting orders, my husband became more brazen with his aggression. He assaulted the person who served him with court papers and even threatened to kill me when we were at the court house.

Looking back on that time, I can see I had so much to learn about domestic violence and the affect it had on me and the kids. From the beginning, the Family Violence Specialist understood how I felt and what I did. She never judged me for the decisions I made. In fact, she helped me to be less judgmental and more understanding to myself.

It seemed natural to blame myself for allowing him to have access into my life again after we did so much to get him out. I felt like a fool for believing in him when he cried and told me he missed our boys and just wanted a chance to be a father. My Today Centre worker has helped me to understand that I made the decision to let him back into our lives because I want my kids to have a relationship with their father. I had the best of intentions, but when the abusive behaviour started happening again, it became even more difficult to stop.

I returned to the Today Centre a **third time** when my husband started using visitation with the children as a manipulation and control tactic. It has been an exhausting time, but I am still able to say that I can see the purpose this experience had in my life. There have been a number of blessings in the journey, two of which are my worker and the Today Centre. Together with my worker we completed two risk assessments and three safety plans. I have moved houses three times, been to court eight times and accessed countless resources.

My worker has been instrumental in helping me to change my life. She is the first person who ever validated and heard me, so now I am able to move on in my life with the ability to trust and validate myself. Not only have I been able to get away from my abusive husband, but now I understand the cycles of abuse and have stopped generational trauma from occurring in the lives of my children.

I can't say thank you enough!



STRATEGIC DIRECTIONS

Our Results

With the transition experienced in the past year, the Today Centre's Strategic Directions for Year 7 Priorities have been extended to allow for a more thoughtful process to be undertaken in developing Strategic Directions beyond December 2017. As part of renewing the Today Centre's Strategic Directions, the Stakeholder Consultation Feedback Report was completed by an external consultant and presented to the Board of Directors in December 2016.

Eighteen community partners and stakeholders were consulted and provided input to support Today Centre's Strategic Directions planning. With appreciation, we thank all who provided valuable feedback. The Stakeholder Consultation Feedback Report resulted in a program review being conducted, which will, in turn, help guide the Strategic Directions process moving into the fall of 2017. Recruitment of a new Executive Director took priority this past year. While efforts were placed into this process, relationships and commitments with existing funders were maintained, an extension of our lease agreement was successfully negotiated and one new volunteer Board member and one new volunteer became a part of the Today Centre team.

INDEPENDENT AUDITOR'S REPORT

To the Members of The Today Family Violence Help Centre

We have audited the accompanying financial statements of The Today Family Violence Help Centre, which comprise the statement of financial position as at March 31, 2017 and the statements of operations, changes in net assets and cash flows for the year then ended, and a summary of significant accounting policies and other explanatory information.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian accounting standards for not-for-profit organizations, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified audit opinion.

Basis for Qualified Opinion

In common with many not-for-profit organizations, The Today Family Violence Help Centre derives revenue from fundraising activities the completeness of which is not susceptible to satisfactory audit verification. Accordingly, verification of these revenues was limited to the amounts recorded in the records of The Today Family Violence Help Centre. Therefore, we were not able to determine whether any adjustments might be necessary to fundraising revenue, excess of revenue over expenses, and cash flows from operations for the year ended March 31, 2017, current assets and net assets as at March 31, 2017.

Qualified Opinion

In our opinion, except for the possible effects of the matter described in the Basis for Qualified Opinion paragraph, the financial statements present fairly, in all material respects, the financial position of The Today Family Violence Help Centre as at March 31, 2017 and the results of its operations and its cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations.




