Integrated response to family violence



Message from Board of Directors

In our third year of operation, Today Centre is still a young sapling trying to strengthen its roots.

There have been false starts, but for every two laid down one has proven effective. Through this trial and error process we have learned a few truisms: We know when individuals must travel to multiple locations to seek help, it's a barrier. We know when they have to tell their story over and over again, it's traumatizing and frustrating. And we know these hurdles are costly and dangerous to those already in distress.

That's why we firmly believe Today Centre — a safe, centrally located hub of supports — is an effective model to help those affected by family violence. But we've faced challenges in offering comprehensive services housed under one roof. For example, in February 2012, changes to partnerships between the City of Edmonton and Edmonton Police Service meant the constables working at Today Centre were relocated. Internally, we were also missing the protocols and systems to effectively deliver services across multiple agencies.

In 2011/2012, we created a three-year business plan to resolve these challenges. The first year's

goal is to expand our collaborative service model. We have hired Emerging Directions Consulting to help us create service delivery principles, build a model for how co-located agencies work together, and formalize a memorandum of understanding between us and the agencies housed at the Centre. With these core organizational systems in place, we can better help those affected with domestic violence.

Financially, our one-year funding commitments don't allow for long-term planning. However, this year we anticipate receiving charitable status for Today Centre, which will increase our potential sources for funding.

At the board level, we'd like to thank two longserving outgoing members Sue Languedoc and Chantile Shannon for their passion and dedication.

In this early growth phase it's easy to forget it takes years for a sapling to plant deep roots. And it's only possible with the patience and nurturing of our staff, partners, funders and board members who believe everyone deserves a life free of abuse. Thank you for your ongoing support and commitment.

Our work

Today Centre is the single point of entry to comprehensive services for those impacted by family violence.

Our resource workers provide telephone and face-to-face intake, assessment, referral and case navigation services to link clients with supports located on-site or in the community.

They offer clients emotional support and help them create a safety plan, identify their rights, and understand the cycle of violence. Together, they also address any related issues, including the need for food, housing, childcare, mental health or addictions counseling.

To reduce barriers in getting help, Today Centre's goal is to house many of these essential services under one roof. This integrated approach replaces what is often a dispersed and complex system of services, and reduces trauma and repeat victimization of those already in distress.

Our results

Today Centre's integrated approach means we:

- Provided assessment, support and referral services through 993 contacts with individuals impacted by family violence
- Made over 900 referrals to community programs and services

Julie finds the courage to leave

Julie's * husband abused her physically and emotionally. He was controlling. He even told one of their children he was going to kill their mother. That's when Julie, 35, applied for an emergency protection order and was referred to the Today Centre.

When Julie met with a Today Centre resource worker, she revealed her husband also stalked her. If she left him, she feared he would follow and find her.

Julie and her resource worker created a detailed safety plan to protect her and her children: She wouldn't tell anyone where she lived, would always keep a cell phone with her, would call 911 immediately if her husband breached the protection order, and would avoid going anywhere alone. Together, they also developed an escape plan should her husband discover her new home.

Emotionally, Julie felt guilty for letting her children live in an abusive home for so long. Her resource worker reminded her that by seeking help, she was breaking the cycle of violence for a healthier, safer future.

After four in-person sessions at Today Centre, Julie left her husband and found a new place to live with her children. She sought counselling for herself and her children through Catholic Social Services, one of Today Centre's referral partners. She was also referred to Legal Aid to pursue a parenting order. Lastly, the resource worker referred Julie to the Edmonton John Howard Outreach program for on-going support to build a new life for her family, free of fear and abuse.

The profile of a "typical" client at Today Centre is female, 30-37 years old, with one or two children.
